I. BIOGRAPHICAL SKETCH

Mr. Ysasi is a Construction Consultant. His expertise includes project planning, scheduling, estimating, cost control, and schedule delay impact analysis. He has been the qualifying party for general engineering and general building contractor licenses in the states of California and Arizona; current California license 892923. He is a recognized consultant in construction management, critical path method schedule analysis, and delay and damage calculations.

Mr. Ysasi had his own general building and carpentry-contracting firm in the Phoenix, Arizona area from 1979 to 1982. Sundt Construction employed Mr. Ysasi from 1983 to 1987 as a senior estimator in its Phoenix office and a project manager in its Tucson office. Mr. Ysasi joined Gosnell Builders in 1987 as a construction executive responsible for projects in California, Nevada, and Arizona. In 1992 Mr. Ysasi organized Ysasi Constructors, a general contracting firm licensed in California and Arizona. The firm constructed a number of building and general engineering projects for public and private sector clients in California and Arizona until 2001. During this time Mr. Ysasi was a member of the Arizona Builders Alliance and The Associated General Contractors of America and served as the chairman of the ABA General Contractors Council and was on the national AGC Surety Bonding Committee.

In 1992 Mr. Ysasi was also retained as construction claims consultant by Gosnell Builders to prepare claims and provide assistant to the legal firms representing Gosnell in litigation. Mr. Ysasi assisted the Gosnell legal counsel with over 200 days of depositions, numerous document productions, three state court trials and 220-day AAA arbitration. In addition, Mr. Ysasi testified as a percipient witness in two of the state court trials, three depositions, and for approximately 12 days at the AAA arbitration.

In 2004, Mr. Ysasi began working as construction consultant with Nitro Associates. Mr. Ysasi works as a Principal Consultant with Nitro Associates providing all levels of construction and claims consulting, including scheduling, claims analysis, mediation participation, critical path method schedule analysis, delay and damage calculations and client management services. In addition, Mr. Ysasi provides expert witness analysis and testimony as it relates to delay, general contractor standard of care, reasonable construction cost, and reasonable value of mechanic's lien.
